You are buying Exempt Market Securities

They are called *exempt market securities* because two parts of securities law do not apply to them. If an issuer wants to sell *exempt market securities* to you:

- the issuer does not have to give you a prospectus (a document that describes the investment in detail and gives you some legal protections), and
- the securities do not have to be sold by an investment dealer registered with a securities regulatory authority.

There are restrictions on your ability to resell *exempt market securities*. *Exempt market securities* are more risky than other securities.

You will receive an offering memorandum and it is important that you read it.

Read the offering memorandum carefully because it has important information about the issuer and its securities. Keep the offering memorandum because you have rights based on it. Talk to a lawyer for details about these rights.

The Subscriber agrees to be bound by any representations and actions made or taken by the Administrator pursuant to this power of attorney permitted by the Trust Agreement and hereby waives any and all defences which may be available to contest, negate or disaffirm any such action of the Administrator taken in good faith under this power of attorney. The Subscriber declares that this power of attorney shall survive and may be exercised during any legal incapacity, mental infirmity, incompetence, or bankruptcy on the Subscriber's part. This power of attorney shall continue on

as long as the attorney and agent is the Administrator of the Trust, and shall terminate thereafter with respect to that attorney or agent upon substitution therefor of a substitute Administrator but shall continue in respect of the substitute Administrator.
